Dear Member,

MCCI will be mounting a Business Delegation to Indonesia between 17th to 21st June 2019 in collaboration with the Embassy of India in Jakarta and visit **Jakarta and Bandung**.

As you may be aware, Indonesia is one of the developed countries in their region. The contemporary ties between India and Indonesia have now evolved into a robust and multi-faceted partnership, marked by regular high-level visits, increasing trade and investments as well as extensive people to people contacts. When Shri Narendra Modi, Hon'ble Prime Minister visited Indonesia in May 2018 at the invitation of the President of Indonesia Mr. Joko Widodo, both Leaders agreed to strengthen cooperation in all areas by establishing a **New Comprehensive Strategic Partnership** to take Indonesia and India's bilateral relationship into a new era. Indonesia has emerged as the **largest trading partner of India in the ASEAN region**. Bilateral trade has increased from US\$ 4.3 billion in 2005-06 to US\$ 20.4 billion in 2017-18. Our programme envisages Joint Sessions with the leading Chambers of Commerce and Industries at Jakarta to be addressed by H.E. Shri Pradeep Kumar Rawat, Ambassador of India in Indonesia followed by B2B meetings, meeting with the Govt. Departments and visits to industries etc. at Jakarta and Bandung.

I am requesting you to kindly join this important Delegation to explore the possibilities of expanding your presence in Indonesia and make the MCCI Business Delegation a grand success. **Please send the details in the enclosed proforma** indicating the sectors in which you may be interested in B2B sessions and meeting government agencies. Detail programme is being worked out in consultation with the Embassy of India in Indonesia.
